What is Directory Information?

Under the provisions of the Federal Family Education Rights and Privacy Act of 1974 (FERPA), Colleges may disclose information about a student designated as "directory information." This information can, by law, be released to the general public and may be listed in the campus directory. SUNY Cobleskill has designated the following as Directory Information:

- Student Name
- Campus, local and home addresses
- Phone number
- Major

- Department
- Dates of Attendance
- Dates of Graduation
- Degrees Awarded

- Awards
- Full-time/part-time Status
 - Email Address
 - Photo ID

No other student information is released to non-university personnel without written permission.

You have the right to withhold disclosure of directory information. By completing this form, you will be requesting that information NOT be released to non-university personnel or listed in the campus directory.

To be considered!

Please consider the consequences of a decision to withhold directory information. Should you decide not to release any of this information; any requests for such information will be refused. Some effects may be:

- · Friends, relatives, faculty or other students will not be able to access your contact information while a student or after you become an alum
- Information will be suppressed, so that if a loan company, perspective employer, family member, etc., inquire about you, they will be informed
 that we have no record.
- Your name will not be included in announcement of honors, awards or in the program for commencement.

Limitations

Confidentiality/Directory Exclusions does not limit access to your file by authorized individuals nor does it apply to employment information. It does not prevent disclosure of personally identifiable information from a student's record to authorized representatives of federal, state, and local agencies, or any of the other exceptions to signed consent found in FERPA regulations. Information can be released to comply with a judicial order or lawfully executed subpoena.
